### Unity of Wimberley Church Family Ownership (CFO)

Year	Event	
2004	<ul> <li>Purchased 43.234 acres and improvements at 455 White Wings Rd.</li> <li>Owner financed until 2008.</li> </ul>	
2008	<ul> <li>Owner financing arrangement ended.</li> <li>Could not secure bank financing.</li> <li>Created CFO program to finance the mortgage.</li> <li>Investment agreements secured by the Church property.</li> </ul>	
2013	<ul> <li>Program reconfigured to offer one standard issue and a 25-year term.</li> <li>First Open Exchange allowed current investors to sell &amp; new investors to buy. Occurs every 5 years.</li> </ul>	
2018	• Second Open Exchange brought 8 new investors into the program.	
2023	<ul> <li>Third Open Exchange Campaign successfully completed with 25 investors.</li> </ul>

- 25 families are currently invested
- \$455,704.09 remaining debt principal January 2024
- **5.25**% interest rate beginning April 1, 2023 for 5 years
- \$11,981 quarterly payout of principal + interest
- \$2,485,730 property value per 2024 Hays County Appraisal District
- BeSquare Bookkeeping transitioning to CFO Administrator role
- Spring 2028 next Open Exchange
